- **1. Welcome and introductions:** A/Chair Emily Addison opened the meeting welcomed all and thanked Deirdre for booking the meeting room.
- **2. Agenda:** the agenda was carried with one addition (locations).

- **3. Minutes:** of June 7th were approved as circulated. Marchand/Hudon **Carried**
- **4. Update from the A/Chair Emily Addison:** Emily noted that meetings of the READ Sept 6 presenters had been held; that the Data Group had been working on the review of the 2014 statistics; that since the consultant's report had been posted to the website there had been a number of queries from the community associations; that the two page summary of the report will now go up on the website; that Ottawa West Community Support Centre is willing to look at the possibility of partnership but would understandably have a number of conditions to be met. Councillor Leiper will take the lead on any further discussions with OWCSC.

Emily reported that a very encouraging meeting had been held with Danielle McDonald to discuss development and financing options. The OPL administration advised that there is no model for a joint facility that would house a library in conjunction with affordable housing. This model would likely take more years to plan than a standalone library. For any partnership development with any social service agency it will be very important to have the provincial government onside as it would involve provincial operating and capital grants.

Emily also reported that much work had been done on a final draft motion between READ and the councillor's office and the final motion had been sent to all the 13 community associations in the READ catchment area. To date 7 CAs have signified their approval; one (Westboro Beach) with suggestions for slight modification. Civic Hospital NA had a number of questions which were answered.

Following Emily's remarks, Richard Van Loon expressed enthusiastic thanks to Emily for taking over the chair while he has been recuperating. A round of applause ensued.

5. READ Presentation to OPL Board Meeting, September 6, 2016

The three presenters (Van Loon, Addision and Nutt) did a read through of their presentations for timing, flow and impact. Suggestions were discussed and will be incorporated into final presentation. Blaine will draft media advisory and arrange to send out Monday evening, Sept 5 in advance of the meeting. Jeanette will be asked to handle the Twitter push-out. The main message is that Rosemount needs more space/new building.

The presentation will be revised with a focus on: recommendation for more space based on research and community input; respect for the current space; answering questions that have already come up from community members and CAs.

The media list (Google contact list "Media") will be revised with suggestions from meeting attendees and twitter handles will be added. It was agreed that the last of the knitted books would be presented to the board members and the CEO at the meeting. A list of possible questions and answers related to the presentation will be prepared. Name tags will be prepared.
