READ Rosemount Meeting #39 Final Minutes Monday May 15, 2018 Time: 7-9 pm

Location: Hintonburg Community Centre, 1064 Wellington W. Lower level.

1. Welcome: Josh welcomed the group

2. Agenda: The agenda was approved as circulated on a motion. LH/PD.

3. Minutes Approval: The minutes of April 23 were approved on a motion. BM/B. Campbell.

4. Update from Chair

Chair Nutt reported that there had not been many changes since the April meeting except some additional information from Monique Desormeaux, Deputy CEO at OPL. She advised that the Rosemount renovation consultations will be in September (or later). Because of the timing of the municipal elections (Monday, October 22, 2018) Councillor Leiper would not be able to participate in the consultations if held in September. At this time there is only one other candidate running in Kitchissippi Ward – Daniel Stringer.

5. READ Future Role and Mandate

Under the direction of the chair, each member was given a time-slot of 3-5 minutes to state his/her views. An email from Linda Hoad was included in the discussion. A vigorous discussion was held. Following are the highlights:

- High level options (not mutually exclusive
 - o Wrap up READ's work.
 - o Declare victory, celebrate accomplishments (first round consultations, doubling of renovation budget).
 - Shift mandate to focus on soft infrastructure issues.
 - Shift mandate to focus on needed service improvements at Rosemount (need for more hours, Sunday service all year-round, programming, technology, use of alternate space in community etc)
 - o Focus on ensuring strong public participation in the upcoming consultations

• It was agreed that:

- No further work would be done on development charges as this is the job of the Library and the City.
- o Important to look to the future and focus on what kind of improved OPL service will be available at Rosemount
- Important to be aware that there are other areas of the city without adequate services (eg. Carleton Heights) that like Rosemount would have little access to development funds. Continue to advocate for a better, more robust long-term capital plan for public libraries in

Ottawa. This is a major budget shortfall for OPL.

- o Discussion will be continued and way-forward finalized at READ's June meeting.
- o Important to maintain a positive attitude and relations with OPL and friends of OPL and our municipal councilor, community associations and other key community groups.
- o Intensification of the Rosemount catchment area will mean increasing pressure for more and better community library service.

Chair will prepare detailed summary. Discussion to be continued at the June READ meeting.

6. Advocacy, Outreach, and Research

- **a. ArtsPark** (Hintonburg): This will be happening June 12. It was decided that READ would not have a booth this year.
- **b. NewsWest:** Confirmed that we will not have an article in the June issue but will plan, with Blaine as lead to have summer articles leading up to the consultation. The timing of the KT/NW issues is changing and Blaine will find out the new schedule and advise us.
- **c. 100th Anniversary:** The West Wellington BIA in partnership with Mizrahi will be presenting the Pop-Up Cinema Series 3 films outdoors in Parkdale Park. On June 11 at 8-11 pm the feature will be The Never Ending Story about the history and development of the Rosemount library. READ is not involved in this presentation. It was determined that READ would consider mounting a photographic series rather than have a celebratory event.
- **d. Rosemount Renovation Project:** Fiona Mitchell advised that the RFP had not yet been sent out. One it has been released there is a submission period of 4-6 weeks and then 4-6 to review and evaluate proposals and decision making. Once an architect is chosen public consultations can begin. This could mean that the community consultation phase might be further pushed out beyond September. Fiona also raised the long term possibility of a larger branch being a feature of the redevelopment of Tunney's Pasture.
- 7. Future READ Meetings. The meetings for the remainder of the Spring 2018 will be as follows:
